## 1. General Information

These Terms & Conditions (“Terms”) govern the provision of CGI BOOST services (“Services”) by AMAL.STUDIO s. r. o. (“Provider”) to the client (“Client”). By placing an order and completing payment, the Client confirms acceptance of these Terms.

## 2. Scope of Services

CGI BOOST is a digital visualization service focused on improving, enhancing, or creating architectural CGI visuals based on materials supplied by the Client. The scope of Services depends on the selected package (Basic, Plus, or Pro) and any additional options selected during checkout.

## 3. Client Responsibilities

The Client is responsible for providing accurate, complete, and usable project materials, including but not limited to drawings, 3D models, reference images, and written notes or instructions. The Provider is not responsible for delays or inaccuracies caused by incomplete or incorrect materials.

## 4. Delivery & Timelines

Delivery timelines are estimates and depend on the selected package, the completeness of provided materials, and the selected delivery option. Express or 24-hour delivery applies only after all required materials have been received and confirmed as complete.

## 5. Revisions

Each CGI BOOST package includes revisions as defined within the selected package. Any additional revisions or changes outside the agreed scope may be subject to additional fees and separate approval.

## 6. Payments

All payments are processed securely via Stripe. Prices are listed excluding VAT unless stated otherwise. VAT is applied in accordance with applicable European Union and Slovak regulations. An invoice is generated automatically upon successful payment.

## 7. Refund Policy

Due to the nature of digital services, payments are non-refundable once production has started. Refund requests submitted prior to production may be reviewed on a case-by-case basis.

## 8. Intellectual Property

Upon full payment, the Client is granted a non-exclusive license to use the delivered visuals for marketing and presentation purposes related to the specific project. The Provider retains the right to showcase the work for portfolio and promotional purposes.

## 9. Liability

The Provider shall not be liable for decisions made based on the delivered visuals, inaccuracies resulting from Client-provided materials, or any indirect or consequential damages. The maximum liability of the Provider is limited to the total amount paid for the Services.
